

REGULATIONS FOR ANIMALS (they do not replace the general regulation, which must always be consulted)

- Animals of all breeds and sizes are welcome in our holiday village. Families with dogs in particular will be offered special housing, equipped with a fenced garden or a gate on the terrace.

- Pets are allowed in all common areas of our village: bar, restaurant and beach included

- Our beach is divided into 2 fully equipped areas, a family area without dogs and a bau beach area. Families who come on holiday with a family pet are entitled to a beach umbrella with 2 sun loungers (see general beach regulations) in the bau beach area, which will remain so for the entire period of their stay even if visiting the beach without Fido.

- Pets can bathe at all hours in the stretch of sea directly in front of the bau beach

- To move about within the premises and on the beach, animals must be strictly kept on a leash.

- You may take your pets to do their business in the special dog area at the end of the car park, all droppings must be promptly collected and disposed of in the appropriate bins, and when possible, water should be thrown on the urine to prevent the spread of bad smells or stains

- If the pet performs an act of need in a non-dedicated area, it does not matter, as long as immediate action is taken as described above

- The dog should never be left alone inside the accommodation unit, but may be left outside the home as long as it does not disturb the peace.

- If the management determines that the animal is disturbing the peace, the owner will be notified. If the situation continues, the management reserves the right to expel the holiday party from the village without providing a refund.

- The management reserves the right to remove aggressive animals and/or animals causing damage to people, property, equipment and other animals from the village. All of this without providing a refund

- At the seaside, it is absolutely forbidden for dogs to relieve themselves, and if it does happen, it must be dealt with immediately.

- Should the dog cause too much noise on the beach, the owner will be asked to ensure that other guests are not excessively disturbed

- It is possible to let your dog loose in the needs/run area and in our agility park

- When you leave the beach you can rinse your dog in the dedicated washing station WITHOUT USING SHAMPOO OR SOAP, we have a coin-operated tub for washing your dog

- The management is not liable for any escapes and/or damage caused by third parties or by the owner himself to his animal

- The management is not liable for any escapes and/or damage caused to property and/or persons by the dog

- In case of litigation, the court of reference is in Teramo

***The present regulations are posted at the entrance. It forms an integral part of the booking contract and the act of entering the property is its tacit acceptance by the Guests. The staff is authorised to enforce it and to report those who do not comply to the management. In the management's opinion, failure to comply with these rules and behaviour that damages the harmony and spirit of the holiday may result in removal from the premises as an unwelcome guest.**
